Dear Valued Customer:

Numerous states have passed hazardous packaging regulations that will impact both the screen printing and supply industries. This legislation, modeled after the Council of State Governments (CSG) toxics reduction legislation, sets limits on the amount of lead, mercury, cadmium and hexavalent chromium that can be found in any package or packaging components. Packaging components have been defined as any individual assembled part of a package, including inks and labels. The CSG has taken over this legislation originated by CONEG (Coalition of Northeastern Governors). Visit their website (www.csg.org) for more information.

Essentially, the law states that no product shall be offered for sale or for promotional purposes in a package that contains levels of the aforementioned heavy metals in excess of 100 parts per million (0.01%), effective January 1, 1994.

Based on information obtained from random test data, Nazdar certifies that the standard colors in the ink lines listed below comply with current CSG regulations regarding content of lead, mercury, cadmium and hexavalent chromium.
